<sup>\*\*</sup> Fee paid on the day during a consultation with a doctor will vary based on the actual appointment length time. Additional fees for medication and contraceptive devices apply. Lost chemist scripts, referrals and requests for Medical Records will also incur a small fee.

<sup>^</sup> IUD booking fees are refundable if you make changes to your IUD insertion appointment at least 48 hours prior. If you cancel your appointment under 48hrs the IUD booking fee will not be refunded however, some consideration will be given under special circumstances.
